

Christian bakers won't pursue £250,000 costs after Supreme Court victory

A Christian-owned bakery in Northern Ireland will not try to recover the six-figure cost of a lengthy - but ultimately successful - legal battle over its refusal to decorate a cake with a pro-gay marriage slogan.

Ashers Baking Company has decided against pursuing a legal costs order against the Equality Commission in Northern Ireland - the public body which initiated proceedings in 2014.



Black Santa will distribute €32,000 - the proceeds of the Dublin Black Santa Appeal at St Ann's Church, Dawson Street - to local good causes at a special service in St Ann's Church, Dublin on Sunday 10th February at 11am. All are welcome. If you contributed why not come along.

The McArthur family, which owns the firm, was defended by legal experts at the Christian Institute. The organisation said it spent more than £250,000 on the case.

In October last year, the family successfully appealed at the Supreme Court in London against previous rulings that it had breached discrimination laws.

The case ignited when a gay rights activist was declined an order for a cake decorated with the words "Support gay



marriage". The McArthurs objected on the grounds of their Christian beliefs.

The McArthurs objected on the grounds of their Christian beliefs.

A ruling by Belfast County Court which found the McArthurs had acted with discrimination was later upheld by the Court of Appeal in Belfast - prompting an appeal bid to the Supreme Court.

But five judges at the Supreme Court determined that the objection Ashers had made was at "being required to promote the message on the cake - not to the man."

During previous stages of the case, Ashers has argued that each side should pay its own costs "because of the wider public importance of the case and because both sides were supported by third parties".

Explaining that decision, the Christian Institute said it did not want to receive a legal costs order at the cost of deterring similar cases being lodged in future.

Director of the Institue, Colin Hart said: "It is important to Ashers and to us that the approach to costs now is consistent with what was previously argued.

"We believe the trend on costs in cases of this nature is a helpful development that improves access to justice.

"In other cases supported by the Institute, costs orders have been avoided or limited. This makes it less expensive to <u>churchnewsireland@gmail.org</u> Page 4

pursue public interest cases like this. That is a principle we hope courts will follow in similar cases in the future.

"Having set a good precedent on the substance of the case in the Supreme Court, we do not want an unhelpful precedent in relation to costs - even if it might benefit in the short term."

Ashers has not be left out of pocket by the court case, thanks to supporters of the Christian Institute.

Black Santa sends Matthew to sea

Wheelchair–bound Matthew Davis from Carrowdore took an exciting sea voyage in 2018, with the help of funding from the Black Santa Sit–out at St Anne's Cathedral.

Matthew, who also has Asperger's Syndrome, is the son of Revd Colin Davis, rector of Carrowdore and Millisle.

He and his cousin Ross signed on as crew on STS Lord Nelson for a 10–day experience at sea with the Jubilee Sailing Trust.

The ship, with 10 permanent crew, signs on 40 crew each voyage – 20 with a physical disability and 20 able bodied who buddy the former.

Lord Nelson and Tenacious (square riggers) are the only tall ships in the world where every aspect of shipboard life is accessible to all.



Special features include speaking compasses to enable visually impaired crew to navigate, joystick assisted steering for those with mobility issues at the helm and fixing points to help wheelchair users get around the ship when at sea.

Volunteers can climb the mast; set the sails; helm the ship; learn navigation skills and cook in the galley. They can also undertake *Leadership at Sea* training under the watchful eye of a crew member.

Although the Trust sails all around the globe, this particular voyage was from Southampton to Belfast by way of Cork

"Matthew had a fantastic time on board ship," says Colin. "It was a tough experience in many ways because everyone has to muck in and take their turn on the watch, but he really

rose to the challenge and has matured through it. We're so grateful he got this amazing opportunity."

Matthew has been in a wheelchair since the age of 14 when he collapsed at school with paralysis from the waist down. Eventually he was diagnosed with transverse myelitis,an inflammation of both sides of one section of the spinal cord. He has made a partial recovery but is still unable to walk.

A former pupil of Mitchell House School, Matthew now attends SERC where he studies IT. As well as a taste for sailing, he also loves to play wheelchair basketball and plays in the Irish League Squad for the Knights Wheelchair Basketball Club."

A grant from 2018's Black Santa Sit–out will again support the work of the Jubilee Sailing Trust with three people from Northern Ireland set to benefit in 2019.

Queen's chaplain reveals racial abuse she's received post-Brexit vote

A chaplain to the Queen has revealed how the climate surrounding Brexit led to her being racially abused on the street for the first time.

Reverend Rose Hudson-Wilkin, who is also the Chaplain to the speaker of the House of Commons, said the current situation had given confidence to the underbelly that has always existed.



Speaking at the Church of England Foundation for Educational Leadership conference, she explained that despite having lived in the UK for decades she had never been racially attacked on the street until last year.

She said: "Whatever happens at the end of that (Brexit) it's about how are we going to keep the nation together.

"Over 30 years I have lived in this country. For the first time, last year, I was shouted at in the street and told to go back to Africa.

"Now I don't come from Africa, so I don't know which country in Africa they wanted me to go back to."

Jamaican-born Rev Hudson-Wilkin added: "So I think there has developed an unpleasantness, there's been an underbelly that has suddenly thought this is our time, we can do this and behave in this manner.

"So whatever happens, remember the vote was very close. Whatever happens at the end of March 29 it doesn't mean that people are going to say 'we've arrived now'.

"So we still need to be the ointment, we still need to be there praying and hoping and longing for the kind of unity that is going to see us down whatever pathway we go."

In her speech to the conference on Thursday Rev Hudson-Wilkin said many politicians would say that currently Parliament is a "rather bruising place to be".

"The verbal attack, the vile abuse targeted on them through the internet, and we know all too well that this can spill over into physical attack not just simply threatened, but real, as in the case of Jo Cox MP who was brutally murdered," she explained.

But she added that parliamentary democracy "is far too precious for us to give up".

However, Rev Hudson-Wilkin continued: "If we are going to be a truly resilient parliamentary democracy, then we are going to have to strongly resist the temptation of resorting to those defaults of behaviour that prevent us working together in a spirit of generosity and trust - the political point scoring, getting one up on the other, the football terrace shouting at one another. churchnewsireland@gmail.org

"We need to regularly engage across the party and ideological divide."

New publication from Veritas to resource the Prayer of the Faithful



Tributes paid following the death of former Church of England evangelist Michael Green

The renowned evangelist, theologian and apologist Dr Michael Green, who once served as senior evangelism advisor to the Archbishops of Canterbury and York, has died in hospital at the age of 88.

"It is with great sadness that I pass on the news that Michael Green went to be with the Lord yesterday Wednesday 6th February at around 3pm at the John Radcliffe Hospital in Oxford", the Director of Ministerial Training at Wycliffe Hall theological college, Greg Downes, said <u>in a statement</u> on Thursday.

"His passing was peaceful and he was surrounded by Rosemary and his immediate family. . . I've just spoken to Rosemary on the phone and prayed with her and she is feeling at peace and grateful for the many messages of support and love that she has received from around the world."

Downes added: "As we grieve with hope (1 Thess 4:13) we give thanks to the Lord for the privilege of being associated with such an amazing man of God and for his incredible legacy."

The Archbishop of Canterbury, <u>Justin Welby, said</u> that Dr Green's legacy was still having an impact on the Church of England. "Later this month the General Synod of the Church of England are meeting at what has been subtitled a 'Synod for Evangelism'", he said. "That evangelism is now being established as a prime priority for every church is partly due to the life and ministry of Michael Green.

"I'm told that from his hospital bed Michael had let his close friends know that, whilst things were complicated medically, God was giving him 'lots of opportunities' to share the gospel.

"Michael was a compelling and consummate evangelist, an example and model to all of the joy and energy that living

and loving the gospel bring to proclaimer and listener. He served the church locally, nationally and internationally through his ministry of communication in speech and writing.

"As the church we are deeply grateful for his tenacious ministry. Beyond telling, however, will be the gratitude of all those that Michael introduced to Jesus Christ – the Lord in whose presence he now knows joy beyond our imagination."

The Bishop of Oxford, <u>Dr Steven Croft, said</u>: "Michael was a giant of his generation, known and loved by many around the world and an evangelist to the last. He inspired and encouraged several generations of clergy and bishops – including me.

"I first heard him preach on my first Sunday as an undergraduate in St Aldate's over 40 years ago. Michael's words then were: 'I only have one life and I want to live it all for God' have stayed with me through the years. May he rest in peace and rise in glory."

The evangelist <u>J John said</u> that Dr Green had "led a life that was so innovative, varied and dynamic that it's hard to summarise what he did. He was – often at the same time – vicar, evangelist, writer and theologian."

He added: "One curious observation of longevity is that you can end up outliving not only your contemporaries but also your achievements. Something of this applies here. Throughout his ministry Michael played a significant part in shaping what is modern evangelicalism in the UK. Yet precisely because many of the battles he heroically fought occurred so long ago, there are many today who are unaware of the role Michael played in creating a culture that they now take for granted.

"Particularly important was the way that, in two key areas, Michael was able to dispel prejudices. One was the belief, widely held until into the 70s, that you couldn't be a scholar and an evangelical, and certainly not one who was passionate for evangelism. Michael had an extraordinarily sharp mind and accumulated academic honours – indeed, had he chosen to be purely a scholar he could have been a professor in any of the great universities – but he remained openly and enthusiastically committed to sharing the good news of Jesus.

"The second widespread preconception was that the only people who believed that the Holy Spirit might be a powerful

and active force in the world today were those who were uneducated and knew no theology. Yet by giving early and outspoken support for the Charismatic Movement when it emerged onto the global scene in the 1960s, Michael demonstrated that to believe in the Holy Spirit did not demand that you ignored theology. The fact that today we take it for granted that you can be spiritual and scholarly and clever and charismatic owes much to his labours."

Ordained a Deacon in 1957, Dr Michael Green served his curacy in Holy Trinity, Eastbourne before becoming lecturer at the London College of Divinity in 1960. In 1969 he became principal at St John's College, Nottingham, an evangelical Anglican theological college; a post he held alongside that of Canon Theologian at Coventry Cathedral. He also served as a member of the C of E's Doctrine Commission, between 1968 and 1977.

In 1975 he became Rector of St Aldate's in Oxford; before moving to Canada to serve as Professor of Evangelism at Regent College, Vancouver in 1987. In 1992 he returned to the UK to serve as the Archbishops' Advisor on Evangelism during the Decade of Evangelism. He retired in 1996 and became Honorary Fellow at Wycliffe Hall. From 2005 to 2007 he served as Co-Rector of Holy Trinity, Raleigh, a church in North Carolina that was formed by people who left the US-based Episcopal Church following the consecration of Bishop Gene Robinson.

Writing on <u>the website of *Premier Christianity* magazine</u>, Evangelist Matthew Fearon, who works with Ravi Zacharias International Ministries, said: "Michael's gift of distilling the complex into the memorable made him one of the most exceptional and accessible evangelists of the last 60 years. "His sense of humour, his infectious joy allowed him to get away with more than most, found deep expression in *You Must Be Joking: Popular Excuses for Avoiding Jesus Christ* (1976). While in books including *Man Alive* (1967), and *Who is this Jesus?* (1998), his lightness of theological touch and intimacy with Christ saw him reach an audience far beyond the Christian community, as well as equipping lay Christian believers in their grasp of the Gospel."

February 9 & 10 in Christian history

February 9, 249 (traditional date): According to Dionysius (died c. 264), bishop of Alexandria, on this date, Roman officials "seized that marvelous aged virgin Apolloinia, broke out all her teeth with blows on her jaws, and piling up a bonfire before the city, threatened to burn her alive if she refused to recite with them their blasphemous sayings. But she asked for a brief delay and without flinching leapt into the fire and was consumed".

February 9, 1881: Russian novelist Fyodor Dostoyevsky dies. A devout Russian Orthodox Christian, the author of Crime and Punishment (1866) and The Brothers Karamazov (1880) once wrote "If someone proved to me that Christ is outside the truth, and that in reality the truth were outside of Christ, then I should prefer to remain with Christ rather than with the truth.

February 10, 60 (traditional date): The Apostle Paul is shipwrecked at Malta

February 10, 1535: A dozen Anabaptists run stark naked through the streets of Amsterdam. Such strange actions, usually by Melchoirite Anabaptists, led to the group's ridicule by Protestants and Catholics alike. Former Catholic priest Menno Simons (1496?-1561) was finally able to bring the



group into a nonresistant, discipled, and disciplined vision (see issue 5: Anabaptists).

February 10, 1751: John Wesley suffers a fall on the icecovered London Bridge and is carried to the home of Mary Vazeille, a sailor's widow. Within a week, the two were married—with disastrous results. The unhappy couple spent so little time together that, in 1771, Wesley recorded this in his journal: "I came to London and was informed that my wife died on Monday. This evening she was buried, though I was not informed of it".
